MEETINGS

a. Meeting of the Standing Committee on Population Welfare was held on 1st April, 2022 under the Chairpersonship of Ms. Nighat Yasmin Orakzai. Director General Population Welfare briefed the Chair on progress of previous meeting held on 23-2-2022.



b. Quarterly Review Meeting of the staff of District Population Welfare Offices and Regional Training Institute was chaired by the Secretary Population Welfare Department, Muhammad Zia-ul-Haq at Directorate General on 26th April, 2022. He stressed upon all the participants to take effective, concrete and innovative steps for the implementation of population programme at grassroots level.



- c. Monthly Progress Review Meetings were held in the quarter April-June under the chairmanship of Secretary and Director General, Population Welfare Department to discuss the following:
- ADP Schemes 2021-22 (Financial and Physical Progress)
- Draft ADP 2022-23
- Monthly Review of UNFPA Activities
- Progress on CCI recommendations.
- d. Meeting on ADP 2021-22 and 2022-23 was chaired by Syed Ahmad Hussain Shah, Special Advisor to Chief Minister on Population Welfare in Directorate General on 31st May 2022. He emphasized that the Department should introduce modern technology mobile application to facilitate better monitoring and accessibility. He further emphasized to ensure transparency and meritbased appointments.



e. Meeting regarding Job Descriptions was chaired by the Secretary Population Welfare Department to improve service delivery of Field Staff and Monitoring of Field activities for improved Service Delivery. f. Virtual Meeting was chaired by the Director General Population Welfare Department with District Population Welfare Officers in May, 2022 to discuss the overall functioning of service delivery outlets and field staff duties.

COORDINATION WITH DEVELOPMENT PARTNERS

a. The Development Partners play a significant role in the financing, design, oversight and implementation of various Family Planning initiatives in the Province. Population Welfare Department is assisted by United Nations Fund for Population Activities (UNFPA), United States Agency for International Development (USAID), Family Planning 2030 and Agha Khan Foundation to further its programme to promote a prosperous, healthy, educated, and knowledge-based society. A meeting was arranged with the implementation partners under the chairmanship of Secretary Population Welfare Department to discuss and strengthen coordination between public and private sector organization for achieving national and international targets on population.



- b. Moreover, collaborative meetings were conducted with Agha Khan Foundation/Sehat Mand Khandaan Project and Provincial Team Leader DAI (USAID). Meetings were also held with Consultants of Health Services Academy (HSA) Islamabad & Forum for Safe Motherhood (FSM) regarding developing Implementation Framework for Reproductive Health Act 2020 and IT solutions for E-Registration of Clients.
- c. Pakistan has been a member of FP2020 since 2012 and made its FP2030 Commitments in line with its national goals agreed under the CCI Recommendations. Fp2030 working group meeting was held under the chairmanship of Secretary Population Welfare Department and was attended by participants from Health Department, Population Welfare Department, Independent Monitoring Unit Health and Development Organizations. Detailed deliberations were held on FP2030 roadmap and the Chair stressed upon greater coordination between public and private sector organizations for achieving national and provincial targets on FP/RH.



d. Secretary PWD also chaired a meeting regarding UNFPA activities in Population Welfare Department, Khyber Pakhtunkhwa. Dr. Jameel Ahmed Chaudhary, National Program Specialist, UNFPA also attended the meeting. Progress on ongoing activities and future possible avenues for collaboration and coordination between the two stakeholders came under discussion. Chair stressed upon launching reforms for improving FP/RH service delivery and thanked UNFPA for technical support and assistance.

MONITORING AND SURPRISE VISITS

Monitoring visits are crucial for measuring the progress of service delivery units and verifying delivery of outputs to achieve results.

a. The Secretary Population Welfare Department, Khyber Pakhtunkhwa, paid monitoring visits to Nowshera, Kohat and Charsadda Offices during May & June, 2022. He inspected the District offices, stores, Family Welfare Centres and Reproductive Health Services Center Type A(RHSC-A). He was briefed about the progress of Family Planning activities. The Secretary Population Welfare Department particularly stressed on the role of the Family Welfare Assistants (Male and Female) to take active part in achieving the desired targets. The Secretary Population Welfare Department also conveyed his desire to visit the rest of the Districts.



- b. The Secretary Population Welfare visited District Population Welfare Offices of Chitral Upper, Chitral Lower, Dir Upper and Dir Lower. He inspected the Family Welfare Centers, checked medicines and its usage, stock position in stores and issued directions. He also visited Regional Training Institute Peshawar and was briefed by the Director General Population Welfare Department.
- c. Director General Population Welfare Department, Khyber Pakhtunkhwa, being operational head, paid a surprise visit to District **D.I Khan** in June, 2022. She inspected RHSC-A, Adolescent Sexual Reproductive Health Center (ASRH) and Family Welfare Centres. She also paid surprise visit to District Population Welfare Office **Abbottabad** and Family Welfare Centres and RHSA at **Haripur**.



d. Additional Director General, paid surprise visits to different Family Welfare Centers of District Bannu and Mohmand in order to ensure attendance and verification of performance especially of FWAs (Male and Female).

RECRUITMENTS, PROMOTIONS & RETIREMENTS


Vacancies were advertised for the posts of Family Welfare Workers and Family Welfare Assistants for the establishment of 260 Family Welfare Centers in Khyber Pakhtunkhwa.



- A project for establishment of 120 new FWCs in the Newly Merged Districts has been approved by PDWP in its meeting held on 16th June, 2022.
- During the second quarter of 2022, 9 personnel were retired and 104 personnel were promoted to different
- Upon the recommendation of Provincial Selection d. Board, one officer of BPS-19 was promoted to ADG (BPS-20) and two BPS-18 officers were promoted to BPS-19.
- A total of 61 new recruitment were carried out in different cadres.
- A restructuring committee meeting was conducted to discuss O & M study of the Field Staff of Population Welfare Department. The case for restructuring of field staff of Population Welfare is forwarded to Finance Department.

FAMILY PLANNING & GENERAL MEDICINES SERVICES

- 212,548 CYP was generated in this quarter. a.
- 379,070 married couples were provided contraceptive b. and family planning services.
- 105,992 clients were provided maternal care. c.
- d. Contraceptive Performance has been increased by 3.13% as compared to last quarter.
- Data collection process for FP/RH survey 2022 was e. completed in 27 districts including the merged districts.



- 753 Health and Hygiene sessions were carried out in Girls High Schools/Colleges.
- 919 Reproductive Health Extension Camps were conducted through Mobile Service Centers.
- 7,455 DTC and Advocacy Meetings were arranged with religious scholars, public representatives and opinion leaders.
- 1,395 satellite camps and 48,009 visits were conducted for motivational purposes by the Family welfare Assistants (FWAs) and Family Welfare Centers (FWC).
- 573 Monitoring and Evaluation (M&E) visits were conducted in the field.
- To revitalize the RHSC-As, where the women medical officers were not available, contraceptive surgery and Jadelle extension camps were initiated by utilizing the services of the existing WMOs. 25 CS/jadelle camps were held in RHSC-As. 126 contraceptive surgeries & 436 implants/jadelle insertions were performed successfully in extension camps.



- The pending joint contraceptive procurement process has been initiated and persued it was pending since August 2021. Rs.320 Million has been allocated for the current financial year.
- m. Under CCI Recommendation of Advocacy and & Communication, media Campaigns were carried out under "Innovative Scheme for Promotion of Population Welfare Program". 21 print media campaigns, 22 TVCs 330 Radio public service messages were broadcasted. Facebook gathered 76,000 and YouTube 154,059 views.
- Toll free No. 0800-44477 is live and information regarding Family planning queries can be obtained.
- 02 step down trainings under ADP project "Involvement of 200 Religious Scholars at Village Council Level in KP" were conducted in district Nowshera. 60 participants in both the step-down trainings were trained on "Islam and Family Planning".
