**F.No.4 (35)/HR/2025/FWW:** On the recommendations of the Departmental Selection Committee, the Competent Authority (Director General Population Welfare, Khyber Pakhtunkhwa) is pleased to offer the Post of Family Welfare Worker (BS-09) on **Temporary** basis to the following Candidates against the Zone/Quota noted against each on the following terms and conditions:-

- i. You will get pay at the minimum of BS-09 (17470-1090-50170) including usual allowances as admissible under the rules and will also be entitled to annual increment as per existing policy.
- ii. You will be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973 as amended from time to time and all the laws applicable to the Civil Servants and Rules made there-under.
- iii. You will, initially, be on probation for a period of one year, in terms of Section 6(1) of Khyber Pakhtunkhwa Civil Servants Act, 1973 read with Rule 15(1) of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 and extendable for another year with the specific orders of appointing authority within two months of the expiry of first year of probation period as specified in Rule-15(2) of Rules ibid.
- iv. In case you wish to resign at any time, fourteen days notice shall be necessary or in lieu thereof fourteen days pay shall be forfeited.
- v. You will produce a medical certificate of fitness from medical Superintendent, Civil Hospital concerned and character certificates from two gazzatted officers.
- vi. Your retention in service shall be subject to an affidavit to the extent of genuine of testimonials and documents and your appointment shall be subject to verification of your domicile, testimonials and antecedents etc. from the concerned authorities/offices.
- vii. Your appointment is liable to be terminated at any time without assigning any reason before the expiry of the period of probation/extended period of probation, if your performance during this period is not found satisfactory.
- viii. You have to join duty at your own expenses, as No TA/DA shall be admissible there-for.
- ix. You may be posted anywhere in Khyber Pakhtunkhwa.
